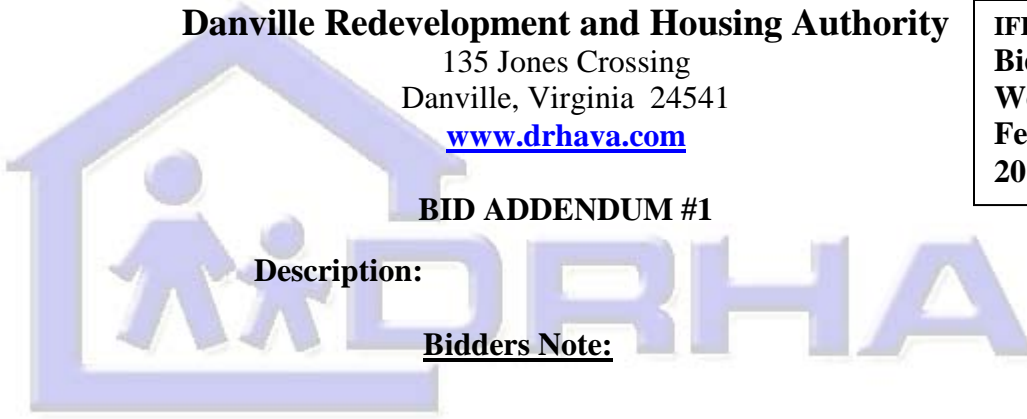

1. The undersigned, having familiarized himself or themselves with the job site conditions affecting the cost of the work, and with the Specifications (Including the Instructions to Bidders, Form of Invitation for Bids, this bid, the Form of Contract, the Special Conditions, the Technical Specifications and Drawings) and Addenda, if any thereto, as prepared by DRHA, and on file in the office of the same, hereby propose to furnish all labor, materials, equipment and services required to perform the floor tile installation at Pleasant View. There is a total of 71 units, which consist of 2 and 3 bedroom units.

2. In submitting this bid, it is understood that the right is reserved by the DRHA to reject any and all bids. If written notice of the acceptance of bid is mailed, telegraphed, or delivered to the undersigned within sixty (60) days after the opening thereof, or at any time thereafter before this bid is withdrawn, the undersigned agrees to execute and deliver a contract in the prescribed form and furnish the required bond within ten (10) days after the contract is presented to him for a signature.
3. The Bidder represents that he ( ) has ( ) has not, participated in a previous contract or subcontract subject to the equal opportunity clause prescribed by Executive Order 10925, 11114, 11246, or the Secretary of Labor, that he ( ) has ( ) has not, filed all required compliance reports; and that representations indicate the submission of required compliance reports , signed by proposed subcontractors, will be obtained prior to a subcontract award. (The above representation need not be submitted in connection with contract or subcontract which are exempt from the clause.)
4. Certification of Nonsegregated Facilities. By signing this bid, the Bidder certifies that he does not maintain or provide for his employees any segregated facilities at any of his establishments, and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The Bidder agrees that a breach of this certification is a violation of the Equal Opportunity clause in this contract. As used in this certification the term "segregated facilities" means any waiting rooms, work areas, rest rooms, and wash rooms, restaurants and other eating areas, time clocks, locker rooms and other

storage and dressing rooms, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated by explicit directive or in fact segregated on the basis of color, religion, or national origin, because of habit local custom or otherwise. He further agrees that (except where he has obtained identical certifications for proposed subcontractors for specific time periods) he will obtain identical certifications from proposed subcontractors prior to the award of subcontract exceeding \$10,000.00 which are not exempt from the provisions of the Equal Opportunity clause, that he will retain such certifications in his file; and that he will forward a notice to his proposed subcontractors as provided in the Instructions to Bidders.

5. The bidding contractor represents that this proposal includes the required MBE goal of twenty percent (20%) minority participation in the construction.
6. The bidders hereby acknowledge receipt of Addendum Numbers, \_\_\_\_\_ and declares that he has notified all sub-bidders of the existence of same.
